**Fear of arbitrary killing / Fear for safety 14 May 1996**

**INDIA Civilian electoral officials in the state of Jammu and Kashmir**

On 11 May 1996 a death threat was publicly issued by seven armed opposition groups operating in the state of Jammu and Kashmir -- *Hizb-ul-Mujahideen, Tehreek-ul-Mujahideen, Al-Jihad, Al-Barq, Hizbollah, Al-Umer* and *Hizb-ul-Momineen* -- threatening with death any civilian electoral official who carries out polling duties during the forthcoming elections in the Kashmir valley.

The statement, issued to the media, declared, "No government employee will take part in the election duties. ... Any official found taking part will be responsible for his death." According to a Reuters report, the joint statement by the armed opposition groups called upon all officials to suspend their duties, "All government and semi-government offices, educational institutions will remain closed from May 13 to May 31, so that no government official is forced to take part in poll duties". Exempted from this were banks, shops, businesses, ambulance services, emergency hospital treatment and waterworks.

On 13 May, in response to the death threat, most government offices and schools in Srinagar remained closed. However, some offices were open and some officials continued to function.

Numerous abuses by armed opposition groups have been reported in recent months, including torture, deliberate killings and hostage-taking. These abuses contravene international humanitarian law which states that the life of civilians be protected, and forbids torture and hostage-taking.

**BACKGROUND INFORMATION**

Polling in the Indian general elections has concluded in all parts of the country with the exception of the state of Jammu and Kashmir. Two polling dates remain, 23 and 30 May, covering the remaining four constituencies in the Kashmir valley.

On 7 May, Amnesty International expressed concern about the escalating levels of human rights abuses in the state, in the context of the election. It called on the government and all armed groups to respect human rights and to stop targeting journalists and human rights defenders monitoring the electoral process. The recent death threat deepens the organization's concern for the safety of civilians in the Kashmir valley, particularly in the period leading up to the dates of polling.

The print media has virtually ceased to operate in the Kashmir valley, in response to censorship that has been imposed by the government and by armed opposition groups, in the run-up to the elections, denying citizens the right to their freedom of expression. On 19 April, the *Hizb-ul-Mujahideen* responded to the government restrictions on the editorial of newspapers, by issuing a warning to editors that they would be "dealt with severely" if they published government statements or advertisements.

In recent weeks all the major newspapers in the Kashmir Valley, including both the major English-language dailies, *Greater Kashmir* and the *Mirror of Kashmir*

and the seven Urdu-language dailies with the largest circulation, have ceased to publish for fear of reprisals.

**RECOMMENDED ACTION: Please send telegrams/faxes/airmail letters in English or your own language:**

- expressing concern for the safety of civilian electoral officials in the state of Jammu and Kashmir;
- calling on *Hizb-ul-Mujahideen, Tehreek-ul-Mujahideen, Al-Jihad, Al-Barq, Hizbollah, Al-Umer* and *Hizb-ul-Momineen* to withdraw the death threat and ensure that no civilian electoral officials are arbitrarily killed;
- calling on all armed opposition groups in Jammu and Kashmir to abide by the principles of international humanitarian law.
